Board Minutes June 1st , 2016

- **President George Dentry** called the meeting to order and asked for **Joe Keyes** to offer the opening prayer.

- **Dave Broecker** provided a Treasurer's report. Bank balances were to be provided later but he provided a report on significant transactions the last month. Pancake Breakfast revenue was \$1,122 and \$3,000 was spent on our annual contribution to the Civic Center from the Activities Fund. No action was taken in the Scholarship fund.

Administrative and promotion activities will be stepped up July 1st with the "Track for Life" organization for the October 15th function. He also replaced our Lions Club sign on the Civic Center property with a new overlay and is working on getting new information

- signs to be placed below the emblem.
- **Justin Gaidusek** suggested we have a new opportunity to provide refreshment stand service with community soccer; he also suggested we consider a golf tournament. He was informed we had golf tournaments in the past which did not work out and this activity was abandoned. He also encouraged us to continue to explore "crit race"; this suggestion seemed to be the feeling of most of the Board members.
- **President George** also suggested officers, especially new officers attend the June 11th Leadership Orientation and New Officer Training in Copperas Cove.
- The meeting adjourned at 9:15 am, the next meeting will be July 6th. **Marvin Williams** will serve as host.
